## YOUR AGREEMENT WITH AMAZING JOURNEYS, LLC

By providing payment, you agree to the terms and conditions of this Agreement. The terms and conditions of this agreement cannot be changed.

<u>Cancellation Policy:</u> Prior to January 24, 2024, there is a \$175 penalty for cancellation. From January 25 – April 17, 2024 there is a \$350 penalty for cancellation. From April 18 – May 16, 2024, the cancellation penalty is the amount of the deposit. From May 17 – June 13, 2024, the cancellation penalty is 25% of the total for the cruise package including any additional hotel nights. From June 14 – July 16, 2024, the cancellation penalty is 50% of the total for the cruise package including any additional hotel nights. From July 17 – August 15, 2024, the cancellation penalty is 75% of the total for the cruise package including any additional hotel nights. From August 16, 2024 or after and "no-shows" will receive no refund. There is no refund in the event of interruption or cancellation after the start of the cruise and pre-cruise nights in Athens. Your decision not to participate on the tour due to State Department advisories, fear of travel, illness, or any other reason will be deemed a cancellation.

<u>Travel Protection</u>: Travel protection is highly recommended for participation in this program. Information will be included in your confirmation letter.

Passport & Visa Requirements: A passport is necessary to travel on this itinerary. It must be valid for six months beyond the last day of the trip. If you don't have a passport or yours will expire soon, we recommend beginning the process of procuring/renewing your passport. If you hold a US passport at this time, a tourist visa is not required for the countries on this itinerary as we will be traveling by cruise ship. If you have a passport from any country other than the United States, we recommend you check to see if any visas are required.

<u>Activity Level:</u> 2 out of 5 – This means you're an on-the-go traveler. You don't want to miss a thing, so walking and standing for 1-2 hours isn't a big deal. You can navigate some hills, steps, cobblestones and uneven ground. You can expect some longer days balanced with free time to recharge or set out on your own.

<u>Vaccines:</u> At this time, the countries on this itinerary do not require any specific vaccinations for international travelers. We recommend you visit a travel clinic or see your health professional to be sure you are up to date on vaccinations needed for international travel. Requirements can change at any time. We will have more details in your confirmation email. It is recommended you bring along an official government issued Covid-19 proof of vaccination card as countries and venues along the way may still require it and there is a possibility you may be denied entry without.

<u>Taxes, Fees & Gratuities:</u> Taxes, surcharges, and government fees are included in the rate and are subject to change.

<u>Air & Transfers:</u> For your flights, it is important that you not purchase airfare until you receive a confirmation letter from Amazing Journeys which will contain specific flight parameters. This tour begins in Athens (ATH) and ends in Trieste (port for Venice VCE). Transfers to the Athens hotel and Venice airport are not included.

<u>Twin Accommodations:</u> Twin accommodations are available if you and a friend are traveling together. When signing up for twin occupancy, should one of the roommates cancel, the remaining traveling roommate will assume the cost of a single supplement. Standard cancellation terms apply to any cancellation.

<u>Dining Preference:</u> Oceania's Riviera features an array of complimentary specialty restaurants and unique dining experiences. The gourmet restaurants each serve a distinctive set of dishes from Continental and wellness-inspired cuisine at The Grand Dining Room, classic French fare at Jaques to Vibrant Asian cuisine at Red Ginger and steakhouse favorites at Polo Grill. There is also the Terrace Café, Waves Grill, Afternoon Tea and Baristas. Don't forget luxurious room service and more!

<u>Fuel Surcharge:</u> Should oil costs go above \$65 per barrel and the cruise lines add fees, Amazing Journeys reserves the right to add them to the cost of the package. The cost will be no more than \$10 per guest per day.

**Exchange Rate:** In the case of currency fluctuations greater than 3%, we reserve the right to adjust our pricing according in order that we may be able to operate the cruise and tours effectively.

<u>Payments:</u> We cannot be responsible for cancelled reservations due to declined credit or debit cards. We accept all major credit cards, personal checks 15 days or more prior to the travel date, cashier's checks, and money orders (checks, cashier's checks and money orders payable in US Dollars).

<u>Iravel Documents</u>: Thoroughly review the itinerary and tickets in their entirety. Verify all passenger accommodations, ascertain that all names are correct, and match the documentation that you will be using for identification. Many travel suppliers require preregistration forms completed online or via fax. These forms must be completed prior to the trip; it is your responsibility to make

Your acceptance of any refund waives the additional remedies. Under no circumstances will we be responsible for damages in excess of the amount paid to us by you. Any dispute arising out of or in connection with this agreement shall be determined solely by the courts in Pittsburgh, Pennsylvania, and you hereby consent to the jurisdiction of said courts. You agree to present any claims against us within 30 days after the tour ends and to file any suit within one year of the incident, and you acknowledge that this expressly limits the applicable statute of limitations to one year. You will be liable for our attorney costs if you are unsuccessful in any legal action against us. You agree to grant us (and third parties with whom we may engage in joint marketing) a worldwide, royalty-free, fully paid up license to use your photographic, video, or digital likeness solely for our promotional and/or commercial purposes.

You are responsible for respecting the authority and following the directions of the tour guide and your Amazing Journeys hosts. We may exclude you from participating in all or any part of the tour if, in our sole discretion, your condition or behavior renders you unfit for the tour or unfit for continuation once the tour has begun (unfitness may include, without limitation, any behavior that, regardless of its cause, is inappropriate or offensive or interferes with the delivery of tour services, or may constitute a hazard or embarrassment; in such case, our liability shall be strictly limited to a refund of the recoverable cost of any unused portion of the tour). **Cancellation by You:** We must receive your cancellation in writing. We will notate your cancellation date as the day we receive a written document in which you make this request. No refund or credit will be given for any unused features or early departures for any reason.
