## YOUR AGREEMENT WITH AMAZING JOURNEYS, LLC

By providing payment, you agree to the terms and conditions of this Agreement. The terms and conditions of this agreement cannot be changed.

**Cancellation Policy:** From the time of deposit until March 11, 2024, there is a \$150 penalty for cancellation. From March 12, 2024 – June 12, 2024, the cancellation penalty is \$850 for the tour and pre/post nights. From June 13, 2024 – July 8, 2024 the cancellation penalty is 50% of the cost of the tour and pre/post nights. From July 9, 2024 – August 7, 2024 the cancellation penalty is 75% of the cost of the tour for the tour and pre/post nights. From August 8, 2024 until the day of travel, the cancellation penalty is 100% of the cost of the tour and pre/post nights. Cancellations made on the day of departure and “no-shows” will receive no refund. There is no refund in the event of interruption or cancellation by the passenger after the start of the journey. Your decision not to participate on the tour due to State Department advisories, fear of travel, illness or any other reason will be deemed a cancellation.

**Travel Protection:** Amazing Journeys recommends you purchase travel protection. Information will be sent with your tour confirmation.

**This trip is for you if:** You're an on-the-go traveler – you don't want to miss a thing, so walking and standing for 2-3 hours isn't a big deal and you're able to walk on a 2.5 hour walking tour at a moderate pace, covering several miles, hills and uneven surfaces. Walking four miles throughout the day is very doable and you can easily climb stairs. You can navigate hills and uneven/wet ground independently, climb up and into various modes of transportation including boats and raised safari vehicles and could handle changes in elevation as high as 6,000 feet. You can expect several early mornings and some longer days balanced with free time to recharge or set out on your own adventure. When traveling in Africa you will encounter warm temperatures. You will be climbing in and out of custom-built safari vehicles on a small ladder several times a day and traveling on bumpy roads. You must be in good health and prepare properly. This trip is not a fit for those who require assistance with walking or who travel on mobility devices.

**Flights & Transfers:** It is important that you not purchase airfare until you receive a confirmation letter from Amazing Journeys which will contain specific flight parameters. This tour begins in Johannesburg (JNB) and ends in Cape Town (CPT). Transfers are included. In Johannesburg the hotel provides shuttle services from the airport to the hotel. In Cape Town, Amazing Journeys will provide transfers from our hotel to the airport (on September 24).

**Twin Accommodations:** Twin accommodations are available if you and a friend are traveling together. When signing up for twin occupancy, should one of the roommates cancel, the remaining traveling roommate will assume the cost of a single supplement. Standard cancellation terms apply to any cancellation.

**Baggage:** Regardless of what your international air carrier permits, each traveler will be limited to one checked suitcase (maximum 44 lbs) for flights within Africa. Your carry-on bag (max 17 lbs) must fit up on the bus and cannot go under the bus. Wheeled carry-ons are not suitable for coach tours so we recommend you use a soft-sided backpack or shoulder bag as your carry-on bag.

**Taxes & Gratuities:** Taxes, surcharges, and government fees are subject to change. Gratuities have been included on this tour and include tips for the tour manager, local guides, safari guides, game lodges, drivers, luggage porters and included meals. Gratuities are not included for housekeeping staff in the hotels and tipping is at your discretion.

**Passport and Visa:** A passport is necessary to travel on this itinerary. It must be valid for six months beyond the last day of the trip. Visas will be required on this itinerary. You must have at least 4 blank pages including two full pages facing each other (not the endorsement pages in the back) in your passport to allow for the entry stamps issued for South Africa, Zimbabwe and Botswana. Please note that visa requirements can change at any time and it is up to the traveler to be aware of visa requirements. More specific information regarding visas will be sent as the trip approaches.

**Vaccines & Precautions:** Malaria prevention is required when visiting Zimbabwe and Botswana. Consult your physician prior to departure. We recommend you visit a travel clinic or see your health professional to be sure you are up to date on vaccinations needed for international travel. Requirements can change at any time. You must bring along an official government issued Covid-19 proof of vaccination card as several countries on this itinerary require it and there is a possibility you may be denied entry without.



**Exchange Rate:** In the case of currency fluctuations of greater than 3%, we reserve the right to adjust our pricing accordingly in order that we may be able to operate the tours effectively.

**Fuel Surcharges:** Should oil costs go above \$65 a barrel and our tour operators adjust the rate of the tours cost accordingly, we reserve the right to adjust the cost of the tour.

**Payments:** We cannot be responsible for cancelled reservations due to declined credit or debit cards. We accept all major credit cards, personal checks 15 days or more prior to the travel date, cashier's checks, and money orders (checks, cashier's checks and money orders payable in US Dollars).

**Travel Documents: Thoroughly review the itinerary and tickets in their entirety.** Verify all passenger accommodations, ascertain that all names are correct, and match the documentation that you will be using for identification. Many travel suppliers require pre-registration forms completed online or via fax. Any dispute arising out of or in connection with this agreement shall be determined solely by the courts in Pittsburgh, Pennsylvania, and you hereby consent to the jurisdiction of said courts. You agree to present any claims against us within 30 days after the tour ends and to file any suit within one year of the incident, and you acknowledge that this expressly limits the applicable statute of limitations to one year. You will be liable for our attorney costs if you are unsuccessful in any legal action against us. You agree to grant us (and third parties with whom we may engage in joint marketing) a worldwide, royalty-free, fully paid up license to use your photographic, video, or digital likeness solely for our promotional and/or commercial purposes.

You are responsible for respecting the authority and following the directions of the tour guide and your Amazing Journeys hosts. We may exclude you from participating in all or any part of the tour if, in our sole discretion, your condition or behavior renders you unfit for the tour or unfit for continuation once the tour has begun (unfitness may include, without limitation, any behavior that, regardless of its cause, is inappropriate or offensive or interferes with the delivery of tour services, or may constitute a hazard or embarrassment; in such case, our liability shall be strictly limited to a refund of the recoverable cost of any unused portion of the tour). Please note that your decision not to travel due to State Department advisories or fear of travel will constitute cancellation by you. No refund or credit will be given for any unused features or early departures for any reason.

**Cancellation by Us:** We may cancel any tour at any time before departure for any reason without limitation. We may cancel if we deem the number of passengers signed up for a given tour to be insufficient to operate the tour. We will make commercially reasonable efforts to keep the itinerary as it has been published; however, the final itinerary may vary due to third parties' schedules, availability, and other factors beyond our control. If a tour is cancelled, we will use reasonable commercial efforts to obtain refunds from the suppliers.
